Education: NAVREF promoted the highest standards of fiscal and operational management as well as good governance among its members in three ways: technical assistance; best practice consultation; annual conference. Staff responded to hundreds of inquires from NAVREF members on a range of topics related to nonprofit governance, fiscal management, VA rules, regulations and guidance, and other topics related to research & education grants and projects management. In addition to responding individually by phone or email, NAVREF staff posted answers and information on the organization's website, and occasionally released information via newsletter. The NAVREF annual conference averages 115 participants from member NPCs and focuses on topics of current and long-term interests in the administration, governance, revenue development and reporting of VA-affiliated NPCs.

Member Communications & Services: NAVREF is a membership organization. Its purpose is to serve the 80 member NPCs through direct and indirect services. Overall, NAVREF is a ready resource for its members accessible through telephone, email, website, and meetings. Regardless of the nature of an inquiry, NAVREF will seek to address the member's need quickly and effectively through staff contact or referral. Over a 25-year history, NAVREF has developed contacts with numerous experts in non-profit governance, finances, grants management, and advocacy. Many of these experts make themselves available to NAVREF and its' members to address emerging issues. NAVREF conducts regular outreach to sites via phone calls and site visits to better understand member concerns and challenges. NAVREF conducts an annual member survey to track issues, trends, and member priorities. NAVREF produces a bi-monthly Newsletter to communicate news, changes, and success to the members. VA PARTNERSHIP: To operate a VA-affiliated NPC requires significant cooperation and collaboration with U.S. Department of Veterans' Affairs at the local medical center level and the central office level. NAVREF facilitated exchanges between VA and its' members by identifying issues/concerns and proposing solutions through engagement with numerous VA offices: Strategic Partnership Office, Office of Research & Development, NonProfit Program Office, Technology Transfer Program, Office of General Counsel, Office of Academic Affiliation, Center for Compassionate Innovation, and Center for Innovation. This partnership extends to hosting VA-led webinars, publishing VA articles in the NAVREF Newsletter, and hosting VA speakers at the annual NAVREF conference. NAVREF also attends VA meetings and presents at VA forums to raise the profile of NPCs and the work of NAVREF. Primary working relationships exist with VA's NonProfit Program Office (NPPO). The Search Committee proposes an initial base salary and fringe benefit package for consideration by the entire board, also providing information on salary benchmark data. Based on this information, the entire board deliberates at a regular or special board meeting, and votes to approve the salary and benefits offer, including an allowable salary range for negotiation with the candidate. The Search Committee extends the final offer package to the candidate, and negotiates any final adjustments within the allowed range approved by the board.

For annual reviews of the CEO compensation and bonus, the NAVREF board chair and vice chair prepare an annual draft list of goals. This list include incentive pay goals beyond the usual performance expectations, with related incentive pay ranges. The draft list is reviewed and
