The 3-day event averages 125 attendees from member organizations and focuses on the most relevant topics related to administration, governance, financial management, human resources, and revenue development. Plenary speakers from the US Congress, Department of Veterans Affairs, National Institutes of Health, and the life sciences industry provide keen insight on developing trends and initiatives. NAVREF also executed a monthly webinar program providing valued educational content for 1.5 hours monthly. The webinar program is member-driven to ensure the most compelling material is addressed. Member Communications & Services: NAVREF is a membership organization focused on ensuring the success of the 76-member non-profit corporations through direct and indirect services. Regardless of the nature of an inquiry, NAVREF addresses the member's need quickly and effectively through staff contact or referral. Over its 26-year history, NAVREF has developed contacts with numerous experts in NPC governance, finances, human resources, grants management, advocacy, and research administration.
